Shotguns will not be used in this trial. An alternative blank shot firing device will be used.

**Conditions of Entry:**

- 1) All championship dogs must be purebred & registered NZKC No. 1
- 2) Minor trials are open to all dogs (NZKC No. 1 Register, or No. 2 Register, or unregistered)
- 3) All dogs entered at the owner's risk.
- 4) Engraving to be the responsibility & cost of the winner.
- 5) The committee reserves the right to alter judges & grounds if required.
- 6) Full pedigree name and registration number must be supplied at time of entry.
- 7) NZGTA Rules and regulations will be available at the Secretary's office
- 8) Eight or more dogs to be entered for third place trophy to be awarded, five or more dogs to be entered for second place to be awarded.
- 9) Retriever Walk Up – this event will be a maximum of 12 dogs. If entries exceed 12 dogs, the club will hold a ballot at the Tai Tapu Pub on the 17<sup>th</sup> January at 6pm.
